No payment of money is required to take part in the Contest. A Contest participant does not need to be a Tournament player.</p>
2.	Employees and agents of the promoters of this Contest (TGC Marketing Sdn. Bhd.) and Samsung, their respective families, households or anyone professionally connected with this Contest (in Samsung's opinion), are not eligible to enter this Contest.
